ITAR Compliance Statement

RH Electronics, Inc. — Export Compliance · Document QCP-02 · Revised 2026

1.0 Statement of Compliance

RH Electronics, Inc. is committed to full compliance with the International Traffic in Arms Regulations (ITAR), 22 CFR Parts 120–130, administered by the U.S. Department of State, Directorate of Defense Trade Controls (DDTC), and with the Export Administration Regulations (EAR), 15 CFR Parts 730–774, administered by the U.S. Department of Commerce, Bureau of Industry and Security (BIS).

2.0 Scope

This statement applies to all RH Electronics personnel, facilities, and operations involved in the purchase, handling, storage, sale, and shipment of components and the associated technical data, where such items may be subject to ITAR or EAR jurisdiction.

3.0 Registration Status

RH Electronics does not currently manufacture, export, temporarily import, or broker defense articles or defense services as defined by the ITAR, and is therefore not required to register with the DDTC under 22 CFR Part 122. Should RH Electronics' activities change such that registration becomes required, RH Electronics will register with the DDTC prior to engaging in any activity that triggers that requirement.

4.0 Access Controls — U.S. Persons

RH Electronics restricts access to ITAR-controlled defense articles and technical data to U.S. persons as defined in 22 CFR 120.62. ITAR-controlled technical data is not released, disclosed, transferred, or otherwise made available to any foreign person, whether located in the United States or abroad, without prior authorization from the DDTC.

5.0 Export Authorization

RH Electronics does not export or re-export defense articles, defense services, or related technical data without the appropriate license or other authorization from the DDTC, or an applicable license

exemption. Items subject to the EAR are reviewed for proper classification and exported only under the appropriate BIS authorization or license exception.

6.0 Restricted-Party and Destination Screening

RH Electronics screens customers, suppliers, and transactions against the U.S. Government Consolidated Screening List — including the Denied Persons List, the Entity List, the Specially Designated Nationals (SDN) List, and the DDTC Debarred List — and observes all embargoed and sanctioned destinations.

7.0 Recordkeeping

RH Electronics maintains records relating to ITAR- and EAR-controlled transactions in accordance with 22 CFR 122.5 and 15 CFR Part 762, and makes such records available to the cognizant U.S. Government agencies upon lawful request.

8.0 Training and Responsibility

RH Electronics maintains an export-compliance program overseen by a designated Empowered Official / Export Compliance Officer and provides periodic training to affected personnel. Suspected violations are reported to the Export Compliance Officer and, where required, voluntarily disclosed to the appropriate U.S. Government agency.
